

## Private ADHD &/or ASD screening assessment and diagnosis.

ADHDNorfolk

Every individual ADHD/ASD (Attention Deficit Hyperactivity Disorder and Autistic Spectrum Disorder) person is unique and experiences the world in their own way. As with many other aspects of human neurodiversity, such as autism, ADHD and ASD have long been framed largely in negative terms.

ADHD and ASD individuals may be to a greater or lesser extent, and with significant individual variability forgetful, absentminded, easily distracted and easily bored. Yet by focusing only on negatives as compared with neuro-typical individuals. It is very easy for those not working with or educated in the complexities of neuro divergence to only focus on the negative aspects of neuro-diversity and not see the positive aspects, such as out of the box thinking, an ability to think abstractly to name just one or two.

ADHD Norfolk and Different Minds UK are independent entities working in partnership with each other to provide the highest level of diagnosis and guidance to neuro-diverse individuals. All ADHD-ASD Norfolk's services are delivered by its partnering organisation Different Minds East Anglia LLP. The clinical team is multi-disciplined consisting of a GMC registered Psychiatrist, Psychologists, Psychotherapists and ADHD coaches/psycho-educators and counsellors.

## Steps to screening and full diagnosis.

- E-mail <u>enquiries@adhdnorfolk.org.uk</u> to book a consultation for your initial screening, at the screening we will screen for both Attention Deficit Hyperactivity Disorder and Autism Spectrum Disorder (ADHD & ASD). If you are unsure that ADHD or ASD is presenting please contact us for a telephone consultation where we can talk to you and guide you before you book a consultation.
- 2. Once you have attended the screening a consultation a report will be sent to you within 21 working days, this may be delayed if you have not provided all the documentation we ask for at the time of the screening.
- 3. If you would like to progress to a full formal diagnosis after you have received the screening report, please email and request a full diagnosis consultation. The diagnosis will be undertaken and led by a GMC registered psychiatrist as part of a multi-disciplinary team.

After your full diagnosis we will write to your GP and advise them of the formal ADHD or ASD diagnosis, then also send you a copy of the diagnosis letter we had sent to your GP by email for you to show the school/university or employer should you wish.

4. Adults (over 17 years of age). We will undertake a full formal diagnosis for you however we do not medicate adults.

Once you have a full diagnosis you should ask your GP if they would kindly refer you to the adult NHS ADHD pathway should you decide that you would like to try medication. Your GP will not be able to offer medication until you have been prescribed ADHD medication initially by an ADHD clinic and titrated and optimised to an appropriate dose.

Although we would be pleased to screen and then diagnose you if you are presenting with ADHD, please do not book with us if you wish to be medicated after diagnosis, you will be able to find a diagnostic clinic on line who will medicate you.

- 5. **Children under 17**. We will refer your child after full ADHD diagnosis to the NHS paediatric service via your GP if you live in Norfolk, as the 2023 Norfolk paediatric protocol for ADHD medication and private clinics directs if you would like to trial medication for your child.
- 6. If you live outside of Norfolk and as you are entering private health care. Should you wish to be prescribed medication for your child we will require your GP to listen to the child's heart sounds and deem that they are normal, and also indicate that at the time of the heart sound check the individual is not presenting with any physical illness.

We will then after diagnosis, if medication is appropriate start medication if our GMC registered psychiatrist prescriber deems medication appropriate.

We will only prescribe Atomoxetine, we will not prescribe stimulant medication and you will be responsible for purchasing any medication prescribed from a normal pharmacy. We will provide you with a private prescription.

Please make sure that your GP will carry out a heart sound check on your child before booking with us. We will not prescribe without the forgoing. For under 17 year old patients who live outside Norfolk, we will once medication is titrated and optimised, write to your GP to request continued prescribing of medication. A GP can accept or decline as that is their right to do so.

- 7. Professional fees.
  - ADHD & ASD screening and report £350.00 payable at the time of booking
  - ADHD full diagnosis after screening £750.00 payable at the time of booking
  - ASD full diagnosis after screening (2 further consultations ADI-R, ADOS-2 and ABAS-3) and comprehensive report £1500.00
  - ADHD coaching/counselling/psycho-education £95.00 per session.
- 8. We offer coaching and psychoeducation sessions for ADHD & ASD in the clinic for individuals, couples and families the cost per session is £95.00. We also offer coaching for individuals at their school, travel charges may be added to the coaching fee.
- 9. One year of medication reviews for ADHD medicated under 17's who are located outside of Norfolk is included in the diagnosis fee. If you require medication reviews and prescriptions after year, one a fee of £200 for the following year will be payable.
- 10. All ADHD-ASD Norfolk's services are delivered by Different Minds East Anglia, our multidisciplinary team consists of a GMC registered psychiatrist, psychologists, psychotherapists, ADHD/ASD coaches and counsellors. We also have a team who will visit and work within schools to assist with coaching neuro-diverse children, or training teachers and SENDco's with regard to neurodiversity.

Our clinic can also offer access to work packages to assist adults within the workplace.

- 11. To assist in alleviating ADHD symptoms physical exercise should be increased and alcohol/recreational narcotics reduced or eliminated. Sugar should also be reduced as far as practicably achievable from your diet.
- 12. Once you have your appointment confirmed and payment has been made any cancellations made within 48 hours of your appointment or failure to attend the clinic at the appointed day and time, will be chargeable in full. Unfortunately we are unable to fill appointments cancelled at short notice.
- 13. Booking a screening appointment confirms that you agree to the terms as set out in this document irrespective of you signing the document, and that all and any documentation given to us by you to assist in the screening and diagnosis,

and any information given by you at the screening and diagnosis will be accurate and true.

- 14. We follow NICE guidelines for diagnosis and diagnose in line with ICD-11 and DSM-V guidance criteria.
- 15. NICE NG87 refers to the National Institute for Health and Care Excellence guidelines on Attention Deficit Hyperactivity Disorder (ADHD) in children, young people, and adults. Specifically, NG87 emphasises the importance of considering ADHD behaviours across two domains.
- 16. In the home setting, NICE recommends that healthcare professionals assess ADHD behaviours within the family environment. This includes understanding how symptoms manifest in day-to-day activities, interactions with family members, and the overall impact on familial relationships and functioning. Assessing ADHD within the home domain allows for a comprehensive understanding of the individual's behaviour in a more relaxed and informal context.


Simultaneously, NICE underscores the significance of evaluating ADHD behaviours in a second domain within the work, school or educational setting or elsewhere. This involves examining the individual's performance, interactions with peers and teachers, and any challenges faced in academic and non-academic activities. Assessing ADHD in both home, school and work and elsewhere environments provides a holistic perspective, ensuring that the diagnosis and subsequent interventions are tailored to the individual's needs across different aspects of their life.

We will also ask that you provide in addition to documentation sent to you for completion, that two statements from others who have known the person being assessed for a significant period sets out how any of the following behaviours may be present in or impair the ADHD person's life. One statement can be from a family member and one from a person in a second domain.

Inattentiveness, Poor concentration, Difficulty focussing, Difficulty sitting still, Blurting out, Multiple job moves, Interrupting conversation, Difficulty with organisation, Being forgetful, Relationship difficulties, Not appearing to listen, Difficulty following instructions, Emotional regulation issues, Zoning out, Easily distracted. Please do not make any appointments with us for ADHD or ASD screening coaching or diagnosis, until you have read this document in full, understand the document and agree to its terms and conditions. Once read and agreed please sign and bring it to your screening consultation.
